

Future structure of the Legal Practice Course Consultation Annex 2 – Content and structure of the existing LPC

The existing LPC is delivered on a full-time basis over one academic year, and on a part-time basis over two academic years. Part-time courses are delivered in various modes: two evenings a week, day release and block delivery at weekends.

LPC students must study three compulsory subjects (business law and practice, litigation, and property law and practice). They must also choose three elective subjects from a range on offer by each provider. Students are taught the legal skills (writing and drafting, interviewing and advising, PLR and advocacy), and they must also study Business Accounts and Solicitors Accounts. Other areas – such as professional conduct, financial services and revenue law – are covered.

LPC providers structure their courses in different ways – what follows is an indication of how a full-time and part-time course might be delivered.
