Legal Aid Sentencing and Punishment of Offenders Act 2012



- Received royal assent 1 May 2012
- Prohibits payment and receipt of referral fees in personal injury cases (sections 56-60)
- Package of measures aimed at reducing the costs of civil litigation

What sort of arrangements will be caught?



3 questions:

- Is there a referral?
- Is there a payment?
- Is the payment *for* the referral?

How do we currently regulate referral fees?



- Referral fees permitted (except in legal aid and criminal cases)
- Subject to our Principles and specific Outcomes, e.g. Requiring transparency, independence and protection of client's interest

Developing our Approach



Key Challenges:

- Consistency with our outcomes-focused, risk-based approach
- Ensure consistency between regulators
- Lack of clarity in LASPO
- Protecting consumers where firms heavily reliant on referral fees could be at risk
- How will the market adapt?
- Policing the Ban
- Joint Marketing Schemes

SRA Proposals



Proposals set out in our Summer Discussion paper were broadly welcomed:

- New mandatory outcomes in the SRA Code of Conduct
- Supported by indicative behaviours
- Read alongside SRA Principles and other outcomes in the Handbook
- Supported by a Supervision and Enforcement Strategy

Consultation – October 2012



- Discusses responses to June discussion document and proposals for dealing with issues raised
- Sets out proposals for implementing LASPO, including revised/new outcomes and indicative behaviours
- Provides information on our interpretation of LASPO for regulatory purposes
